## Our privacy policy is simple:

- We respect your privacy.
- We follow applicable law, such as the Data Protection Act 2018 and the 2018 GDPR.
- WPTRNPT LTD. is NOT collecting any data (personalised or not personalised) from you in our products for storage on WPTRNPT LTD. servers.
- Our website is NOT using WPTRNPT LTD. cookies or showing any third party ads. We are NOT currently using any third party website performance analytics tool. There is the possibility on our websites to be directed to YouTube to watch videos that further explain some of our product features. If you choose those options, YouTube, exactly like when you normally use YouTube, may place cookies (short pieces of information) onto your browser that help performance but also might track personal information from you and could be used for targeted advertising. Please refer to YouTube's privacy policy as to your options around such cookies. You do not have to watch those videos to understand our products, our website or Apple Store product videos explain all features and you can always contact us with questions.
- We are NOT currently offering any advertising option in products that would allow you to access extended features for free. Therefore NO personalised or non-personalised information is gathered for advertising purposes through third parties.
- When you buy or use our products, exactly like any other app you use, Apple Inc. HAS to collect data relating to your use of our products, for example, data whether you purchased extended features. Data collection that is beyond being necessary can be changed in your device settings. We refer you to Apple's privacy policy for that.
- To enhance your experience with our products, you may personalise the product and our products may help you to personalise the experience, for example by saving your product specific settings on your own devices for future use. We do not have or want any insight into such information. This is your information for your use and your usage enhancement.
- Should YOU choose to contact us, we will use your E-mail address and content solely in relation to the reason of your email. Once that reason has elapsed, we will delete your
